

## 3D Kitchen Ltd. - End User License Agreement

This is a legal agreement between you, the user, and 3D Kitchen Ltd. BY CLICKING ON THE "I AGREE" BUTTON, OPENING THE SEALED DISK PACKAGE, INSTALLING OR OTHERWISE USING THE SOFTWARE PRODUCT, YOU ARE AGREEING TO BE BOUND BY THE TERMS OF THIS LICENSE AGREEMENT. IF YOU DO NOT AGREE TO ALL OF THE TERMS OF THIS LICENSE AGREEMENT, CLICK THE "I DO NOT AGREE" BUTTON AND THE INSTALLATION PROCESS WILL NOT CONTINUE OR PROMPTLY RETURN THE UNOPENED DISK PACKAGE AND THE ACCOMPANYING ITEMS (including written materials and binders or other containers) TO THE PLACE YOU OBTAINED THEM FOR A FULL REFUND IF APPLICABLE.

1. GRANT OF LICENSE - This 3D Kitchen Design Software License agreement ("License") permits you to use one copy of the 3D Kitchen Design Software products acquired with this License ("SOFTWARE") on any single computer, provided the SOFTWARE is in use on only one computer at any time. If you have multiple Licenses for the SOFTWARE, then at any time you may have as many copies of the SOFTWARE in use as you have Licenses. The SOFTWARE is "in use" on a computer when it is loaded into the temporary memory (i.e. RAM) or installed into the permanent memory (e.g. hard disk, CD ROM, or other storage device) of that computer, except that a copy installed on a network server for the sole purpose of distribution to other computers is not "in use". If the anticipated number of users of the SOFTWARE will exceed the number of applicable Licenses, then you must have a reasonable mechanism or process in place to assure that the number of persons using the SOFTWARE concurrently does not exceed the number of Licenses. The present License is granted on the condition that 3D Kitchen Ltd. remains sole owner of the SOFTWARE product.

2. COPYRIGHT - The SOFTWARE is owned by 3D Kitchen Ltd. and is protected by laws, international treaty provisions, and all other applicable national laws. Therefore, you must treat the SOFTWARE like any other copyrighted material (e.g., a book) except that if the software is not copy protected you may either (a) make one copy of the SOFTWARE solely for backup or archival purposes, or (b) transfer the SOFTWARE to a single hard disk provided you keep the original solely for backup or archival purposes. You may not copy the product manual(s) or written materials accompanying the SOFTWARE.

3. DUAL-MEDIA SOFTWARE. You may receive the SOFTWARE PRODUCT in more than one medium. Regardless of the type or size of medium you receive, you may use only one medium that is appropriate for your single computer. You may not use or install the other medium on another computer. You may not loan, rent, lease, or otherwise transfer the other medium to another user, except as part of the permanent transfer of the SOFTWARE PRODUCT.

4. OTHER RESTRICTIONS - You may not rent or lease the SOFTWARE, but you may transfer your rights under this 3D Kitchen Design Software License Agreement on a permanent basis provided you retain no copies, you transfer all of the SOFTWARE product including all written materials, AND the recipient agrees to the terms of this Agreement. You may not reverse engineer, de-compile or disassemble the SOFTWARE. Any transfer must include the most recent update and all prior versions.

LIMITED WARRANTY - 3D Kitchen Ltd. warrants that (a) any 3D Kitchen Design Software disk or written documentation accompanying the SOFTWARE will be free from defects in materials under normal use and service for a period of 90 days from the date of receipt; (b) any 3D Kitchen Design Software supplied hardware accompanying the SOFTWARE will be free from defects in materials under normal use and service for a period of one year from the date of receipt. Any implied warranties on the SOFTWARE and hardware are limited to 90 days and one (1) year, respectively.

CUSTOMER REMEDIES - 3D Kitchen Design Software's entire liability and your exclusive remedy shall be, at 3D Kitchen Design Software's option, either (a) return of the price paid or (b) repair or replacement of the SOFTWARE or hardware that does not meet 3D Kitchen Design Software's Warranty and which is returned to 3D Kitchen Ltd. with a copy of your receipt. This Limited Warranty is void if failure of the SOFTWARE or hardware has resulted from accident, abused, or misapplication. Any replacement SOFTWARE will be warranted for the remainder of the original warranty period of 30 days, whichever is longer.

NO OTHER WARRANTIES - 3D Kitchen LTD. DISCLAIMS ALL OTHER WARRANTIES, EITHER EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO IMPLIED WARRANTIES OR MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, WITH RESPECT TO THE SOFTWARE, THE ACCOMPANYING PRODUCT MANUAL(S) AND WRITTEN MATERIALS, AND ANY ACCOMPANYING HARDWARE. THIS LIMITED WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS.
